



## 2010 Flying Scholarship

### Application Form

#### About the Scholarship

Bathurst Aero Club was founded in 1938 with a membership of just 10. In those 72 years since it has grown to 120 members, a majority of whom are pilots. The club owns a large hanger and a very good club room complex at Bathurst Regional Airport. The club obtained a liquor licence in 1979 and as well as the flying side also holds numerous social activities throughout the year.

The club purchased their first aircraft in 1967 and since then has owned many aeroplanes, mainly Cessna and Piper. The club has been involved in flying training since its inception in 1938 and many of its members have made careers in aviation. Some have gone to the air force, some to the airlines and others to careers in general aviation.

The club is proud to be a co-sponsor with Central West Flying in providing a scholarship to Recreational Aviation Australia's Pilot Certificate. The scholarship includes up to 35 hours of flying in a Jabiru J160 aircraft, all instructor briefings (both flying and theory), all text books and notes necessary to satisfactorily complete the course. The value of this scholarship is approximately \$7,000.00.

#### Application Criteria

Experience:	No previous experience required.
Education:	No minimum educational requirements other than the ability to grasp new concepts.
Language:	A good command of the English language as required by CASA.
Age:	Although there is no age limit it is expected that the applicant will be able to utilise the privileges of the pilot certificate for many years to come.
Residence:	Resident of the Central Tablelands or Blue Mountains.
Time Frame:	Must have the ability to allocate the time required to complete ground briefings, ground theory courses when scheduled and flight training by the 18 <sup>th</sup> June, 2011.

31 <sup>st</sup> May, 2010	Trial Instructional Flight to be completed. (\$70.00 Flight fee will apply)
1 <sup>st</sup> June, 2010	Study notes released to short listed candidates via email.
5 <sup>th</sup> /6 <sup>th</sup> June, 2010	Short test of study notes and panel interview.
7 <sup>th</sup> June, 2010	Finalist advised via email and medical arranged. (No cost to applicant)
18 <sup>th</sup> June, 2010	Awardee publicly announced at Bathurst Aero Club function.

I hereby indemnify and agree to keep indemnified CWF, BAC, Recreational Aviation Australia, their directors, servants, agents, instructors and pilots and each of them against all actions, liabilities, claims, costs and expenses which they may suffer, incur or sustain, in connection with, or arising in any way whatsoever out of the activities referred to in this indemnity.

Nothing in this indemnity shall be read or applied so as to exclude, restrict or modify or have the effect of excluding, restricting or modifying any condition, warranty, right or remedy implied or operating by law (including the Trade Practices Act 1974) and which by law cannot be excluded, restricted or modified.
